2024 MAPCC CEMENTS THE AGRI-FOOD SYSTEMS TRANSFORMATION AGENDA

The Ministry of Agriculture, in partnership with the MwAPATA Institute, the National Planning Commission (NPC), and other partners organized the 2024 Malawi Agricultural Productivity and Commercialization Conference (MAPCC) at the Bingu International Convention Centre (BICC) in Lilongwe from 11th to 12th September 2024. (From page I) ... plays a crucial role in promoting the first pillar of Malawi's long-term vision, MW2063, centered on increasing agricultural productivity and commercialization. This year's conference themed "*Transforming Agrifood* Systems to Generate Worth for All" was graced by the Minister of Agriculture Hon. Sam Dalitso Kawale MP.

In his remarks the Minister of Agriculture, Hon. Sam Dalitso Kawale highlighted the necessity for collaboration among stakeholders to overcome challenges and drive transformative change in food systems.

Hon. Sam Kawale further asked stakeholders in the key agri-food systems to collaborate and network strategically in leveraging their inputs during the conference to achieve the Malawi 2063 goals.

"As we move forward, collaboration will be vital because transforming the agri-food systems will not rely on one person or a single institution. As a Ministry, we will work tirelessly to develop a policy framework enabling all relevant stakeholders to work effectively," Hon. Kawale concluded.

The 2024 MAPCC offered a unique opportunity for stakeholders to engage meaningfully and explore collectively in identifying ways of attaining agri-food systems transformation in the face of the increasing frequency and intensity of extreme weather events in Malawi.

Over 400 participants attended the conference including representatives from government ministries, departments, and agencies (MDAs), scientists, farmers, experts, farmers' organizations, the donor community, civil society, private companies, non-governmental organizations, academia, research institutions, and the media. 27% of the participants were from the private sector, 26% from the NGOs, 25% from the MDAs, 15% from the academia and research institutions, and 7% from the donor institutions.

Forest Plantation Fees Structure Report Launched

On 10th September 2024, the Vice President of the Republic of Malawi, Right. Honorable Dr. Michael Usi launched the Forest Plantation Fees Structure Report from the research that was conducted by the MwAPATA Institute in partnership with the Modern Cooking for Health Forests (MCHF) project funded by USAID and UKAid. The launch took place at the Forest Plantations Conference held at Ufulu Gardens in Lilongwe. In this event, the presentation of research findings and discussions took center stage, focusing on exploring opportunities and practical solutions to the challenges hindering investment in Malawi's forest plantations. Additionally, the gathering fostered dialogue between public and private stakeholders, enhancing mutual understanding of each other's challenges and opportunities, while also aiming to identify effective strategies to strengthen the growth of Malawi's plantation forests. During the presentation of the report, Dr. Maggie Munthali, a Research Fellow at the MwAPATA Institute, highlighted that Malawi's forest plantation fees are lower than those in the surrounding region. In his remarks during the conference, the Vice President called on stakeholders within the forest plantation industry to quickly report any corrupt individuals who are hindering the sector's progress in Malawi.

MwAPATA Institute Disseminates Pro-Youth Agriculture Policy Research Outcomes

Dr Maggie Munthali, a Research Fellow at MwAPATA Institute, interacted with the youths on 3rd August 2024 at the Bingu International Convention Centre (BICC) in Lilongwe during the Regional Dialogue on African Agribusiness Youth Strategy (AAYS) organized by African Youth Union Commission, AGRA-Sustainably Growing Africa's Food Systems, and SADC. In her presentation Dr. Munthali shared the institute's findings on "Youth Engagement in Agriculture and Food Systems in Malawi: Extent, Challenges and Opportunities". She encouraged young attendees to pursue commercial opportunities in the agricultural sector.

Later, on 5th August 2024, the MwAPATA Institute held a Media Briefing at its offices in Area 10, in collaboration with the National Youth Council of Malawi (NYCOM). During the briefing Dr. Munthali highlighted findings policy the and recommendations from a Policy Brief titled "Prospects and Barriers to Youth Engagement in Agriculture and Agri-food Systems." Echoing Dr. Munthali's insights, NYCOM Executive Director Mr. Rex Chapota stated that the study's insights are crucial for identifying stakeholders who can help promote agriculture among youth. "We are currently drafting our strategic plan and these findings will inform some of our pathways to bringing back the youths in agriculture", said Chapota.

Additionally, Dr. Munthali served as a speaker at the side event on "Leveraging Youth Innovations for Sustainable Agri-Food Systems and Healthy Diets in Africa" during the 2024 Africa Food Systems Forum (AFSF), held at the Youth Dome in the Kigali Convention Center (KCC) in Rwanda on Monday, 2nd September 2024. She was joined by two Technical Support Team Members from Michigan State University, Dr. Milu Muyanga and Dr. William Burke, representing the MwAPATA Institute. Furthermore, on 12th September 2024, Dr. Munthali presented on "The Role of Women and Youth in Agri-food Systems Transformation" at the 2024 MAPCC at BICC in Lilongwe.

MwAPATA Study Recommends Soil Fertility Management Interventions to the Affordable Input Program

In partnership with the Ministry of Agriculture and the University of Malawi, MwAPATA Institute conducted a study funded by the Partnership for Economic Policy (PEP) to assess the impact of integrating Soil Fertility Management Interventions (SFMIs) in the Affordable Input Program (AIP). The study's findings were presented by MwAPATA Institute's Research Fellow Dr. Christone Nyondo at the 32nd International Conference of Agricultural Economists held in New Delhi, India, from August 2-7, 2024.

According to the study, despite Malawi's implementation of the Farm Input Subsidy Program (FISP) since the 2004/2005 season, maize productivity remains below potential due to poor soil health. The study demonstrated that adding organic fertilizers and agricultural lime to the Affordable Input Program (AIP) inputs improves maize yields.

"Through the PPVC training, I have also come to learn the importance of engaging public and private players for a buy-in of the policy analysis results", she added. According to her, she is now determined to apply the tools and skills she acquired during the training to enhance her current policy research analysis.

MwAPATA Institute together with the Civil Society Organisation Nutrition Alliance (CSONA), Civil Society Agriculture Network (CISANET), and the Malawi Government, conducted participatory Food Systems Visioning and Planning workshops in Chikwawa, Dedza, and Mzimba districts as part of the Transformative Initiative (TI) which is funded by GIZ Malawi.

The visioning workshops conducted between July and September 2024 saw the TI team engaging key food systems stakeholders from the district and community levels including sector heads from agriculture, nutrition, health and security as well as traders in creating a shared five-year vision and plan for an improved local food sysyem.

Led by the Director of Planning and Development (DPD), at the district

level and the Traditional Authorities (TAs) at the community level, the stakeholders in each district collectively created a vision for a transformed food system to be achieved by 2030. The TI team observed several common elements across the vision statements from the three districts, including improved inclusiveness, knowledge, skills, infrastructure, security services, and enhanced coordination and networking among service providers.

Representing MwAPATA in the visioning workshops were Dinah Salonga, Mercy Phiri Mikanda, and Blessme Phiri. The sessions were facilitated by Facilitators of Change Interventions (FOCI), contracted by GIZ Malawi.
